## 4 – 6 Month Beginner Puppy Competition Open to all Greyhounds puppies 4-6 months old.

The Four-to-Six Month Puppy competition is for dogs that are four months of age and over but under six months on the day of the event. This Class will not be divided by sex in this competition. Puppies bandaged, taped, glued or stitched anywhere including ears or tail will not be judged.

#### Section 2 – Entry and Eligibility

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows or conformation B- matches at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the
  event including the same day as the event and must be listed in the premium list, entry
  form and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
   FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.

#### Section 3 - Titles

The Certificate of Merit (CM) title is an introductory title to AKC conformation events. ........Entrants shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Winners of the Best of Breed ..... will be awarded points toward the CM title based on the number of dogs competing in their breed or variety. Winners of Best of Opposite Sex to Best of Breed in each of the individual breeds or varieties will be awarded points toward the CM title based on the number of dogs competing in their sex. Best Four-to-Six Puppy in Show will be eligible for the highest number of points earned by any breed entered.

The Certificate of Merit requires 15 points awarded in accordance with the following points structure. Dogs Competing Points: 2>1; 4> 2; 8>3; 12>4; 16>5

The Puppy of Achievement (POA) certificate is an introductory certificate to AKC conformation events. Entrants in each breed or variety listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Winners of the Best of Breed in each of the individual breeds or varieties will be awarded points toward the POA certificate based on the number of dogs competing in their breed or variety. Winners of Best of Opposite Sex to Best of Breed in each of the individual breeds or varieties will be awarded points toward the POA certificate based on the number of dogs competing in their sex. Group winners will be eligible for the highest number of points earned by any breed within that Group. Best Four-to-Six Puppy in Show will be eligible for the highest number of points earned by any breed entered.

## AKC National Owner-Handled Series

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are

not professional handlers\*. All dogs that are owner-handled and are not solely owned or exhibited by professional handlers meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligi- ble at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book and the catalog. Dogs must be handled throughout the breed level competi- tion for the regular show by an eligible owner. Professional handlers, household members and current assistants\*\* to professional handlers may not exhibit the dog in this competition.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be the Owner-Handled Best of Breed.
- If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner- Handled Best of Breed.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog and Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and nonregular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the oppo- site sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed including Winners Dog or Winners Bitch as the Best of Breed for the AKC National Owner-Handled Series.
- \*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertise or presented themselves as handling dogs for pay within the last five years.
- \*\* A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

#### NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

The first place winners in non-regular classes which have been undefeated in any other class will be eligible for Best of Breed Competition. (Classes for both Dogs & Bitches). At an independent breed specialty show when there is no competition beyond Best of Breed, a dog or bitch that is 7 years or older and has been spayed or neutered may compete.

#### 80000, JUNIOR SHOWMANSHIP COMPETITION

Junior Handlers who win a third Novice Class with competition present or a first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open, after the closing of entries for a show, are required to transfer their entry from the Novice Class to the Open Class. Must notify the Superintendent/Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

NOVICE INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS: For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS: For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

Master Class: This class will be for Boys and Girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 7 (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in AKC.
