**NO SMOKING ALLOWED INSIDE THE SHOW FACILITY.**

**TRIAL HOURS** 30 minutes following completion of Agility Trial until 30 minutes after last run

**NO SMOKING ALLOWED INSIDE THE SHOW FACILITY.**

**RETURNED CHECKS** do not constitute a valid entry fee. **A charge of \$35.00** will be made for each returned check.

**ERRORS ON ENTRIES**-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.

**TELEPHONE, EMAILED AND UNSIGNED ENTRIES** cannot be accepted.

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS** without the Agreement and Rules are **NOT ACCEPTABLE**.

**ENTRIES RECEIVED WITHOUT FEES** will not be accepted.

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**REFUNDS:** Refunds are allowed if requested before the closing date. Refunds after closing date for bitches in season only. All refunds must include owner's name and mailing address with request.

**TRANSFERS** allowed in accordance with Obedience Rules Ch. 1, Section 16a & b, and Rally Rules Ch. 1, Section 15.

**DOGS** when applied herein means either sex.

**THE CURRENT PRESIDENT**, National Specialty Show Chairperson, Co-Show Chairperson and members of the Bench Show Committee, and members of their household, shall not exhibit, nor cause to be exhibited, dogs they own, or co-own, in competitive classes at this National Specialty Show. The Agility/Obedience/Rally/Triathlon trial secretary and/or chairperson may exhibit, or cause to be exhibited, dogs they own, or co-own, in competitive classes at the National Specialty Show and affiliated events.

**THE AFGHAN HOUND CLUB OF AMERICA RESERVES THE RIGHT TO TAKE CORRECTIVE ACTION** against any individual(s) who engage in inappropriate conduct prejudicial to the interest of the sport of purebred dogs, or the Club, as determined by Club officials, and/or the Event Committee. Individuals who engage in disruptive or aggressive conduct at any event during the National Specialty will be subject to corrective action, including discipline and/or expulsion from the event. Should the Event Committee determine that expulsion is the appropriate course of action, refunds will not be given.

**ALL RIGHTS TO TELEVISION, VIDEO TAPE, ADVERTISE, PHOTOGRAPH, PROMOTE** or otherwise exploit this event are vested in the Afghan Hound Club of America, Inc., or in persons to whom assignments of such rights have been made in writing by the Club. All persons and animals on the Show Grounds at any time while the show is in progress, do by attending this show or participating therein, grant to the Club the right to photograph, televise, video tape, or otherwise use their likeness and voice in any manner without further release or consent.

**JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS.** The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**TRIAL COMMITTEE** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

**DOGS PARTICIPATING**- This trial is open to all Afghan Hounds over the age of 6 months that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP). Dogs must be physically sound. Dogs that are blind or deaf shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Due to space limitations ONLY Dogs that are entered in the trial are permitted on show grounds.

**BITCHES IN SEASON** are not eligible to participate or be in the Trial Room before or during competition. Entry fees will be refunded. Notification for refund of entry fees for bitches in season must be provided to the Trial Secretary in writing at least 30 minutes prior to the start of the first class for the day.

**Fix and Go On (FNG)** As outlined in AKC Obedience Rules and Regulations Effective 2/29/2021, FNG allows the handler to choose to use a "Fix n' Go" option once, which allows the exhibitor to immediately reattempt a single individual exercise. This allows the team to reattempt that one exercise, and then leave the ring on a positive note. Using FNG will result in a non-qualifying score. Fix 'N Go is not pre-entered; rather, it occurs during the course of the run.
