## **ROUTES TO THE SHOW**

**From Northern NJ & NY** - NY State Thruway at Suffern NY/Mahwah, NJ, take I-287 South thru intersection with I-78 East/West to Exit 17 (Routes 202/206 South). Follow signs for Route 202 South toward Flemington NJ then follow signs for **Route 12 West** (around 3 traffic circles) to Frenchtown. Stay on Route 12 West approximately 8 to 9 miles to traffic light at Route 519. Turn left onto Route 519 (Kingwood Road) toward Stockton NJ and go approximately 1.2 miles (Kingwood Township School on left). Turn right onto Spring Hill Road for 1.4 miles then turn right onto Horseshoe Bend Road. Entrance 0.2 miles on left, follow to large Morton Building.

**From Southern NJ & NJ Shore Area** - Go north on Garden State Parkway (Exit 127) or New Jersey Turnpike (Exit 10) to I-287 North. Take I-287 North to Exit 14B (Route 22 West) to Route 202/206 South and follow to Route 202 South to Flemington then follow directions "From Northern NJ" above.

**From Philadelphia Area, Southern PA, DE, VA, etc.** - I-95 North across Delaware River to NJ Exit 1, Route 29 North. Continue on Route 29 North into Frenchtown and onto Route 12 East. Continue on Route 12 East (Kingwood Ave), make slight right onto Horseshoe Bend Road to park entrance on right.

**From Eastern PA** - Route 202 North across Delaware River to Lambertville to Route 29 North. Continue on Route 29 North into Frenchtown and onto Route 12 East then follow directions "From Philadelphia" above.

**From Allentown, Easton & Western PA** - I-78/Route 22 East to Clinton NJ to Route 31 South to Flemington. At intersection/circle of Route 202, follow signs to Route 12 West then follow directions "From Northern NJ" above.

**From NW NJ & NE PA** - Route 46 East from I-80 at Delaware Water Gap to traffic light for Route 31 South. Take Route 31 South 17 miles to Clinton NJ, then follow direction "From Allentown" above.

- **ENTRIES CLOSE AT THE SUPERINTENDENT/SHOW SECRETARY'S OFFICE,** by 7:00pm on Wednesday, February 16, 2022 after which time entries cannot be accepted, altered, canceled, or substituted.
- **ENTRY FORM MUST BE SIGNED** at the bottom by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted. **OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.
- **MAKE ALL CHECKS & money orders payable to Erie Canine Event Services (ECES)**
- **RETURNED CHECKS** do not constitute a valid entry fee. The Trial Secretary will add a collection fee to the amount of each returned check.
- **OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors. There are PDF fillable forms on the Erie website!
- **Per AKC Rules, Chapter 11, Section 2, a recording fee OF \$50** is to be collected **on the first entry only for each dog, each day. An Event Service fee of \$3.00** will be required for each regular class each dog is entered at any Licensed or Member Club Show, Obedience Trial, Rally Trial or Tracking Test. These Fees are included in the entry fee. .

- **NO ENTRY FEES** will be returned if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the management. Entry fees shall not be refunded in the event the dog is absent, disqualified, excused by veterinarian or judge, or barred from the competition by action of the Show Committee.
- **DOGS MUST BE READY FOR JUDGING.** The Club or Show Secretary will not be responsible and is not obligated to furnish any service for notifying exhibitors or their agents of class judging. Judges will not wait for any dog holding up a class. Owner or agents are responsible for the presence of their dogs in the judging ring.
- **DOGS MAY ARRIVE ANY TIME PRIOR** to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.
- **NO ENTRY SHALL BE MADE** and no entry shall be accepted which specifies any conditions as to its acceptance.
- **NO REFUND ON DUPLICATE ENTRIES.** Every effort will be made to find duplicate entries, but if an entry has been processed, no refund will be made.
- **THE SHOW-GIVING CLUB, THE SHOW SECRETARY,** their agents and employees, etc., assume no responsibility for any loss, damage or injury, sustained by exhibitors, handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.
- There are rules that apply for dogs entered in more than one class at any one conformation dog show. From the AKC Rule Book Chapter 3 Section 13: Only Undeclared dogs can compete for winners or Best of Breed. Entering 2 classes and not winning both makes you ineligible to move forward. Same with Non-Reg classes. I.e.. Entering Veterans and BOB. IF you don't win the Vet Class you are ineligible to show in BOB.
- **ALL AWARDS MUST BE CLAIMED** at the Show or they become the property of the Berkshire Valley Basset Hound Club. None will be mailed.
- **ALL DOGS PRESENT MUST BE HELD ON LEASH** or confined to their crates except when being judged or when in the exercise ring. All handlers are asked to clean up after their own dog.

**Veteran Dog/Bitch** – For dogs and bitches that are seven (7) years old or older on the date of the show.

**Field Trial Dog/Bitch** – For dog and bitches that have placed in a REGULAR Stake at an AKC member or licensed Field Trial, other than puppy.

Winners of these classes are eligible to compete for Best of Breed if not previously defeated in the Regular Classes.

**Awards of Merit are offered based upon entries in Best of Breed as follows:**

- If there are 05-14 Basset Hounds competing for Best of Breed competition (includes winners dog & bitch and non-regular class winners), 1 Award of Merit may be given.
- 15-24 Basset Hounds competing for Best of Breed, 2 Awards of Merit may be given.
- 25-34 Basset Hounds competing for Best of Breed, 3 Awards of Merit may be given.
- 35-44 Basset Hounds competing for Best of Breed, 4 Awards of Merit may be given.
- 45 + Basset Hounds competing for Best of Breed, 5 Awards of Merit may be given.

All Awards of merit are at the discretion of the judge.

## AKC NATIONAL OWNER-HANDLER SERIES (NOHS)



***Remember to check the box at the bottom of the entry form participate - or, if entering on-line check the NOHS box.***

***The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.***

- All dogs that are owner-handled and are not solely owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is "Owner-Handled" eligible at the time of entry on the entry form. Eligible dogs will be indicated with an asterisk in the Steward's book and the catalog.
- **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in this competition.**
- Owner-Handled Best of Breed/Variety will be selected from the dogs that are eligible to compete in the Best of Breed/Variety competition including Winners Dog, Winners Bitch and winners of the non-regular classes. However -
- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed/Variety nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed/Variety including Winners Dog or Winners Bitch as the Best of Breed/Variety for the AKC National Owner-Handled Series.
- If the Best of Winners is eligible, the other Winners are ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.
- The breed will not be represented in the Owner-Handled Group (for an all breed show) if there is no eligible dog competing in the Best of Breed/Variety or in Best of Winners competition.

Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years, A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

## JUNIOR SHOWMANSHIP COMPETITION

AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club - PHONE (919) 854-0136.

**Novice Junior Class**-For boys and girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**Novice Intermediate Class**-For boys and girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**Novice Senior Class**-For boys and girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**Open Junior Class**-For boys and girls who are at least 10 years old and under 14 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Junior Showmanship Class at a licensed or member show.

**Open Intermediate Class**-For boys and girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Junior Showmanship Class at a licensed or member show.

**Open Senior Class**-For boys and girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Junior Showmanship Class at a licensed or member show.

**Master Class** will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.
